The Office of the Municipal Executive, Kalyanpur has allocated funds towards the cost of Construction of 15
Bedded Primary Hospital and intends to apply part of the funds to cover eligible payments under the Contract
for the construction of 15 Bedded Primary Hospital. Bidding is open to all eligible Nepali bidders.

The Office of the Municipal Executive, Kalyanpur invites electronic bids from eligible bidders for the
construction of Primary Hospital under National Competitive Bidding – Single Stage Two Envelope Bidding
procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 16,00,00,000.00 (Sixteen Crore only)
- Minimum Work experience of similar size and nature: One Number within the last 5 years, each with a value of at least Nrs. 17,04,00,000.00 (Seventeen Crore Four Lakh only).
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of *Khadak Municipality, Office of the Municipal Executive Kalyanpur, Saptari*, or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 4. Bidder should submit their bid electronically and can download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders submitting their bid electronically should deposit the Scanned copy of Bank Voucher of Non Refundable fee Nrs 10,000.00 shall be uploaded by the bidder at the time of electronic submission of the bid.

- 5. Pre-bid meeting shall be held at *Office of the Municipal Executive, Kalyanpur, Saptari at14:00 Hours on 25th April 2022 (2079/01/12).*
- 6. Electronic bids must be submitted to the office *Khadak Municipality*, *Office of the Municipal Executive Kalyanpur*, *Saptari* through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 hours on 6th May 2022 (2079/01/23).
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 hours on 6th May 2022 (2079/01/23). at the office of Khadak Municipal Executive Kalyanpur ,Saptari. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of Nrs. 64,00,000.00 (Sixty-Four Lakhs only) which shall be valid for 30 days beyond the validity period of the bid (i.e 150 days).
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
