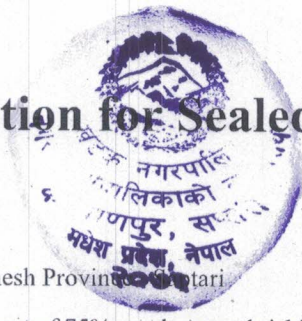

If hard copy is allowed then a complete set of Bidding Documents may be purchased from the office Khadak Municipality Kalyanpur, Saptari, Madhesh Province Saptari and the office Khadak Municipality Kalyanpur, Saptari, Madhesh Province Saptari by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs.1000.0 till 01-07-2026 12:00 during office hours.

5. Sealed bids must be submitted to the office Khadak Municipality Kalyanpur, Saptari, Madhesh Province Saptari by hand or through e-GP system i.e [www.bopatra.gov.np/egp](http://www.bopatra.gov.np/egp) on or before 01-07-2026 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01-07-2026 13:00 at the office of Khadak Municipality Kalyanpur, Saptari, Madhesh Province Saptari Madhesh Pradesh Nepal.  
Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of 50000.00 , which shall be valid for 30 days beyond the validity period of the bid (i.e. [Refer Clause ITB 20.1]). If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.[1103701508004047] at [Agricultural Development Bank Ltd. , Kalyanpur, Saptari, Madhesh Province] and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
